For example, when children can think flexibly and shift their attention to consider different aspects of a social situation, they are better able to solve the problem they are facing.

In Sweden, preschool education is known as "förskola" and is available to all children between the ages of one and five. Preschool education in Sweden is highly valued and is considered an important part of the country's welfare system.
